## What is Will Custody?

## (1) Where should I store my Will?

A Will is one of the most important documents that ensures your wishes will be carried out to take care of your estate matters.

You should store your Will in a safe and secure location to protect it from being destroyed, stolen or lost from unforeseen events.

## 2 Why should I store my Will with Precepts?

Precepts Will Custody is a trusted service where Wills are stored in a secured facility proven to be fire-safe with comprehensive environmental control conditions to safeguard your Will.

### Frequently Asked Questions

#### 1. Why is storing my Will at home risky?

The Will might be destroyed in a house fire, or stolen by relatives or family members who harbour ill intentions.

In TTK vs. TPM (2002, SGHC 152), it was reported by the court that when the third brother of the family knew that his mother had written a Will and kept it in his brother's house, he stormed into the house and searched through all the drawers for the Will. This heightened family tension and bitter quarrels created stress upon the demise of the mother.

Storing your Will with Precepts Will Custody prevents prying eyes of family members, relatives, or friends who may not have the best intentions.

#### Can I keep my Will in a home safe?

In 2018, a house fire broke out in Serangoon which burnt their home safe. This family lost currency notes worth more than \$10,000 and other important contents.

A typical home safe is only effective against theft, but usually lacks protection against fires.

#### 3. Should I store my Will in a bank safe?

If you are the sole account holder of a safe deposit ("bank safe"), the bank will not allow anyone else to access it without a grant of probate.

For your family to obtain a grant of probate, your original Will must be presented to the court.

If your Will is stored in the bank safe, your family would not be able to retrieve this legal document to obtain the grant of probate. Thus, this creates an administrative problem for your family members as they would need to file for additional court procedures to resolve this matter

Storing your Will with Precepts Will Custody solves this problem and allows your appointed executor to gain full access to your Will upon your demise.

### 4. I would like to safe keep the Will myself. Are there implications if I misplaced it?

Yes, the original Will is the only document recognised by the Court. Hence, it is important to safe keep it well. If your family members are unable to locate your Will, they would not know your original intentions and could be burdened with huge costs and complicated legal processes thereafter to manage your estate.

It would be more convenient to make sure your Will is kept safe and secure from the beginning.
